PROBATION

In order to be placed on probation you have plead guilty or have been found guilty in a Court of law and a sentence of probation has been entered. A sentence of probation will consist of a term of probation not to exceed two (2) years and may include conditions and programs that the defendant must complete during the probation term. All probation terms and conditions are overseen by the St. Louis County Department of Justice Services, although the defendant may not need to report regularly to a probation officer.

There are two (2) kinds of probation; Suspended Execution of Sentence (SES) and Suspended Imposition of Sentence (SIS).

SES probation is a conviction and will appear on your record. A sentence is entered by the judge, but execution of that sentence is suspended pending the successful completion of the probation term. The judge may assess a fine and Court costs in addition to the probation term.

SIS probation is not a conviction. A sentence is not entered pending the successful completion of the probation term. The judge may assess Court costs but may not assess fine. Commercial driver's license holders are not eligible for SIS probation.

Terms and conditions are modifiable by the Court on its own motion or may grant a request to modify filed by the prosecution or defendant following a hearing.

If you are placed on probation you need to contact the Department of Justice Services within two (2) business days following the issuance of the order.

PROBATION REVOCATION

Any ordered probation may be revoked following a hearing. If any of the ordered probation conditions are alleged to have been violated and reported to the Court or on the Court's own motion the probation term can be suspended pending the outcome of the probation revocation hearing. If an alleged probation violation report is filed with the Court a copy of the report and notice of hearing will be mailed to the defendant or defendant's counsel.

If it is determined that the probationer has violated any terms of probation, the sentence may be imposed if on SIS probation or executed if on SES probation. The probation term may also be continued with no changes to the current term or conditions, the term extended or conditions may be added or modified.

PROGRAM COMPLETION

The Court may order one or more programs to be completed. This does not result in the defendant being placed on probation and the defendant does not need to report to the Department of Justice Services. Once the Court ordered program is successfully completed, the defendant must return to court and provide proof of completion to the Court for the charge to be amended or dismissed. If the ordered program is not completed within the time allowed by the Court, the defendant does not appear in court to request additional time to complete the program or the defendant does not appear in court to provide proof of completion to the Court, a warrant may be issued for the arrest of the defendant.

COSTS

The defendant is responsible for all costs associated with probation and ordered programs, but may speak to the judge regarding alternative options if the defendant is found to be indigent.
